High school transcripts are **not official until after your graduation date and that date** must be published on the transcript.

☐ 5. **Complete New Student Orientation.**

New Student Orientation is a required step to getting registered for classes. This is held in two formats, online and in-person. 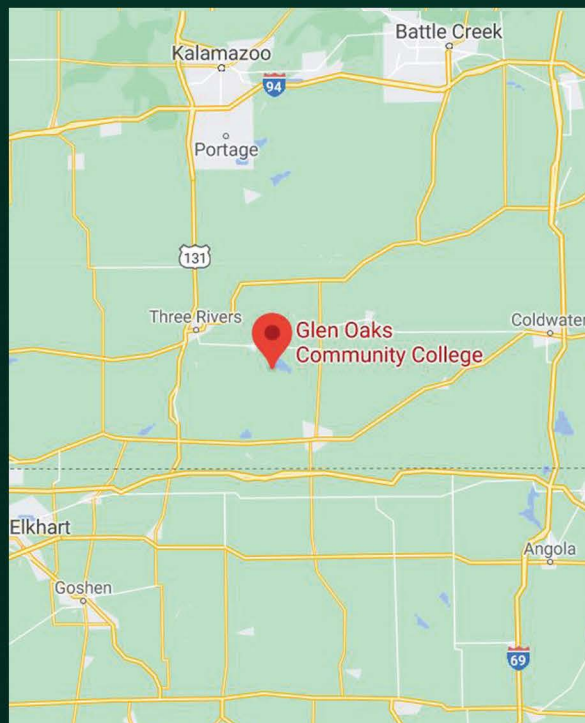
